### 2. Processed data

We collect your data strictly in accordance with the legal requirements in the EU and Switzerland. The legal basis is Art. 6 (1) (a) and (b) GDPR and Art. 13 (1) of the Swiss Federal Act on Data Protection (FADP) respectively.

#### 2.1 General processing

Our websites collect a series of general data each time they are accessed. This general data and information is stored in the log files of the server. The following data is processed:

- IP-address
- Date and time of the request
- Time-zone difference to GMT time-zone
- Content of the request
- Access status/http status code
- Quantity of transferred data

- Website from which the request originated
- Browser (including language and version)
- Operating system

When this general data is processed, it is not assigned to a specific person. The collection of this data is technically necessary to display our website and to ensure its stability and security.

## **2.2 Contact form**

Our website contains a contact form that can be used to contact us. The data entered in the contact form will be stored for the purpose of processing or contacting the person making contact. These data will not be passed on to third parties.

## **3. Cookies**

Our website uses cookies, small text files that are stored on your computer and can be retrieved there. Cookies are used to enable you to log-in to our services and to personalise the website for you. The cookies collect information about your IP address, the time and duration of your visit, the number of visits, web-form usage, your search settings, your display view, your preference settings on our website. The storage time of the cookies varies. We log every access to our website and every retrieval of a file stored on the website. The legal basis is Art. 6 (1) (f) GDPR and Art. 13 (1) FADP respectively.

You can prevent the setting of cookies on our website at any time through the appropriate setting in your internet browser. Furthermore, cookies that have already been stored can be deleted at any time in your internet browser preferences. If you choose to disable all cookies, the functionality of our website may be limited.
